Included herewith is the required \$50 deposit; I understand that 75% of the deposit is refundable before April 15, 2012 (February 1st for Spring Break). Deposits are non-refundable after April 15th. I agree to pay the remaining balance of the camp fee in full no later than June 15th, 2012 (March 1st for Spring Break). We will not hold a space past June 15th without full payment. I understand that after June 15th 50% of the total camp fee is refundable 3 weeks prior to the start of my child's session. Transferring my child to another session of camp is allowed provided space is available and a written request is received at least 3 weeks prior to the start of their original session. I understand that no refunds are given if a child leaves camp early for any reason, drops within 3 weeks of their session start date or does not show up on the first day of camp.
